3. (C) EUSTACIO RODRIGUEZ'S WHEREABOUTS (NO. 3 ON POLITICAL PRISONER LIST) HAD PREVIOSULY BEEN UNCONFIRMED AND HE WAS THOUGHT BY SOME TO HAVE DIED FOLLOWING TORTURE. THERE IS SOME REASON TO BELIEVE THAT INFORMATION EXTRACTED FROM HIM MAY HAVE LED TO THE "DISAPPEARANCE" OF TWO OTHER PARAGUAYAN COMMUNIST PARTY LEADERS, ANTONIO MAIDANA AND EMILIO ROA IN BUENOS AIRES IN AUGUST 1980. EMBASSY ASUNCION HAS NO INFORMATION TO SUPPORT CLAIMS THAT THE ARGENTINE AUTHORITIES HAVE HANDED THEM OVER TO PARAGUAY.

(C) THE TWO NEW NAMES ON THE ARBITRARY IMPRISONMENT LIST, NO. 6 EUGENIO FLEYTAS AND NO. 9 GEORGE SARAMENT, WERE REPUTED IN THE PRESS TO BE CASES INVOLIVING REVENGE ON THE PART OF PERSONS WELL-CONNECTED WITH THE GOVERNMENT. THE CASE OF EUGENIO FLEYTAS IS PARTICULARLY SORDID. HIS MOTHER AND FATHER WERE REPORTEDLY MURDERED IN A FARM COLONY BY A LOCAL POLICE OFFICIAL FOR NOT SELLING THEIR COTTON TO THE DELEGADO DEL GOBIERNO OF VILLARRICA, RAMON LEGAL, WHO IS THE BROTHER OF PRESIDENT STROESSNER'S FAVORITE MISTRESS. FLEYTAS' 11 AND 12-YEAR-OLD BROTHERS ALLEGEDLY HAD BEEN BEATEN BY LOCAL POLICE AUTHORITIES FOR TELLING WHO HAD MURDERED THEIR PARENTS.
